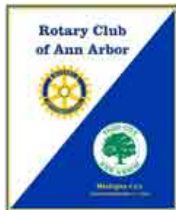

**Topic:** Environmental & Economic Benefits of Great Lakes Restoration

In our first program of the new year, we will learn about the perils that afflict the Great Lakes, how they best can be remedied and at what cost, and the economic as well as environmental benefits of fixing these problems before it's too late. An independent Brookings Institution study, funded by the Joyce, MacArthur, Consumers Energy & Dow Chemical Foundations, concluded that \$26 billion of public investment in Great Lakes restoration would yield at least \$50 billion in long term economic benefits and \$30 to \$50 billion of additional short-term economic activity in the region. Get the details from one of the study's authors, Brookings Fellow John Austin, and the heads of two of the sponsoring organizations.
